SUBJECT: FILLING UP OF THIRTY SIX POSTS OF DATA PROCESSING ASSISTANTS GRADE 'A' IN AFHQ, MINISTRY OF DEFENCE ON DEPUTATION BASIS.

I am directed to say that thirty six (36) posts of Data Processing Assistants Grade 'A' (General Central Service, Group 'B', Non-Gazetted, Non-Ministerial) in the Pay Band-2 carrying Grade pay ₹ 4200/- are required to be filled in AFHQ on deputation basis on the following conditions: -

DEPUTATION

Officers under the Central Government: -

(a) (i) Holding analogous posts on regular basis;

OR

(ii) With 6 years' regular service in posts in the Grade Pay of ₹ 2800/- or equivalent

AND

(b). Possessing the following educational qualifications and experience: -

ESSENTIAL:

- (i) Bachelor's degree with Mathematics/Mathematical Statistics/Statistics/Science (with physics as main subject)/Electronics/Computer Science of a recognised University or equivalent.
- (ii) Diploma/Certificate in Computer Application from a recognised Institution, or knowledge of programming, System Operations and System Analyst (to be judged through suitable tests).

2. **Job Profile** Brief particulars of duties assigned to the post of Data Processing Assistant 'A' are as under :-

(a) Assistance in the design, development and implementation of information systems and databases.

(b) Operations and analysis thereon including assistance to system analysis programming and data organisation, data collection, collation, validation, & coding processing.

(c) Maintenance of all forms of data including alpha-numerical, textual, graphic, voice and optical.

(d) Operation of any type of EDP machine/computer/computer based equipment/computer based instrument/computer based online or real time systems/computer network based systems etc.

3. The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.



The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/Department of the Central Government shall ordinarily not exceed **04** years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of the receipt of applications. The appointment on deputation shall be governed by DOP&T OM No. 6/8/2009-Estt.(Pay II) dated 17 Jun 2010 and its subsequent amendments, if any.

5. It is requested that the applications (in duplicate) in the enclosed proforma along with the complete and up-to-date CR dossiers or photocopies of ACRs for the last **05 years** (duly attested by an officer not below the rank of Under Secretary) and Integrity Certificate (duly verified by an officer not below the rank of Deputy Secretary) of the officers who could be spared in the event of their selection may be sent so as to reach this office within **60** days of the date of publication of this advertisement. Applications received late or without the ACRs, Integrity Certificate, Cadre Clearance and Vigilance Clearance or otherwise found incomplete will not be considered. While forwarding the applications, it may be verified and certified by the Cadre Controlling Authority that the particulars furnished by the officer are correct and that no disciplinary/vigilance case is pending or contemplated against the officer. It must also be certified that honesty and integrity of the officer is satisfactory and no major/minor penalty has been awarded to him during the last 10 years.
